- 6) The Kansas Quarter Horse Racing Association reserves the right to cancel, postpone, change dates or distance of this race for any reason which it deems good and sufficient.
- 7) The KQHRA also reserves the right to, at its discretion, transfer this race to any track situated in the United States.

There will be no refund of fees. All checks returned by the bank will constitute no payment.

**2-YEAR-OLD FOALS BY THESE STALLIONS ARE ELIGIBLE TO BE NOMINATED TO THE KS JACKPOT PREP FUTURITY**

**EXCEPTION:** Should the mare presented to the stallion by the person who purchased the service not conceive the first year the purchaser will have the right to present the same or a substitute mare (in the case of death or breeding unsoundness) to the same stallion the second year. This, and only this, resulting foal will be allowed to move its eligibility to the following years race. No other foals will be allowed to change eligibility years unless the stallion meets all requirements the following year. It is the purchasers responsibility to report to the KQHRA secretary if the mare is not in foal, aborts, dies or foal is still born.

**The KQHRA, the host track and the state -racing jurisdiction are not responsible for stal lions inadvertently left off this list.**

## KANSAS STAKES RULES AND REGULATIONS

**A CURRENT COPY OF THE AQHA REGISTRATION CERTIFICATE AND ALL OWNERS AND PARTNERS OF HORSES (AS SHOWN ON THE AQHA REGISTRATION CERTIFICATE INCLUDING EACH PARTNER OF A PARTNERSHIP) BEING NOMINATED MUST BE CURRENT MEMBERS OF KQHRA. MEMBERSHIP DUES MUST BE MAILED WITH THE ORIGINAL NOMINATION.**

All rules or new rules adopted by the stateracing jurisdiction supersede any condition of this race. Races will be run according to the rules and regulations of the participating racing jurisdiction, the host track and The Kansas Quarter Horse Racing Association (KQHRA). The undersigned represents that he/she and all persons for whom he/she is acting have read and are familiar with the rules of racing and regulations of the participating racing jurisdiction and the horse racing officials, and that all animals are subject to the same and to the acts and decisions of the racing officials, and agree to be bound by the following terms and conditions. All stable reservations and entries in stakes and all other races received and accepted are subject to all conditions, rules and regulations of the participating racing jurisdiction, the host track and KQHRA.

### ELIMINATIONS

Each trial shall consist of not more than ten horses. The trials shall be raced under the same conditions as the stake. KQHRA and the host track reserve the right to schedule additional trial days if necessary. If one day of trials, the ten fastest times will qualify for the finals. The next ten fastest times will qualify for the consolation. If two days of trials, the five fastest times each day will qualify for the finals. The next five fastest times each day will qualify for the consolation. The host track will make every effort to insure that the entries into the trials will be separated by owners and trainers as equally as possible whether one or two days of trials. However, owners and trainers are RESPONSIBLE for timely registration of foal certificates in the racing office with ownership and horse CORRECTLY identified on the foal certificate.

Times of horses in separate trials will be determined by the electric timer. In the event horses in the same trial race are given identical times, the selection of which horses will participate will be determined by the order of finish posted by the State Stewards. No adjustments will be made in the recorded time of trials for head wind, tail wind, off track, etc. Should a mechanical failure occur within the electric timer on any time trials, finalists from that trial will then be determined by official hand timing, with stop watches operated by three (3) official, reputable and disinterested persons. If for any reason a tie exists, the horses involved shall draw lots to determine which shall participate in the finals. Should a horse be disqualified, the horse will be given the time of the horse he is immediately placed behind plus 1/100 of one second. If a front stall gate fails to open due to mechanical failure, or if a horse is left behind the gate when the field is dispatched during the running of the trials said horse shall be declared a nonstarter and no liability is incurred beyond refund of nominating, sustaining and entry fees from the purse to the owner of said horse. During the running of the finals or consolation such horse will be declared a nonstarter and shall be classified as a scratched horse and shall be paid last place money in said race. The decision of the stewards in all matters shall be final and entries accepted only on the condition that those persons nominating or starting a horse in the trials and/or stakes agree to abide by their decision. If any part of an entry is disqualified, it may disqualify all of the entry.

### FINALS & CONSOLATION ELIGIBILITY

Except in the case of a disqualification for a positive drug test report, ineligibility of the horse according to the conditions of the race or a disqualification by the board of stewards for a rule violation other than interference in the running of the race, there will be no also eligible list for the final of the race. Should a horse be disqualified for a positive drug test report, ineligibility of the horse according to the conditions of the race or a disqualification by the board of stewards for a rule violation other than interference in the running of the race, the next fastest qualifier shall assume the disqualified horse's position in the final. If a horse should be scratched from the time trials, the horse's owner will not be eligible for a refund of the fees paid. If a horse that qualified for the final is ineligible to enter the final or should be scratched for any reason other than a rule violation, the owner will receive last place money. If more than one horse should be scratched from the final for any reason other than a rule violation, the money shall be added together and divided equally among those owners. In order to present a full field to the wagering public KQHRA and the host track reserves the right to cancel the running of the consolation. If a consolation race is canceled, all moneys will be divided between those qualifying for the consolation. Those entering back into the consolation will divide equally the purse money for that number of entries. The remaining purse money will be divided equally among those entries whose owners scratched out of the consolation.

**IMPORTANT NOTICE:** The host track reserves the right to schedule an earlier post time on trial days. KQHRA reserves the right to cancel, postpone, change the dates, location, or distance of the race for any reason which it deems good and sufficient. Only in the event of a cancellation will, all nomination, sustaining fees, and penalty fees, minus 12% administration and advertising, be refunded. Interest will be retained by KQHRA. There will be no refund of membership dues. The KQHRA also reserves the right to, at its discretion, transfer this race to any track situated in the United States. Any owner may nominate as many entries as desired. If one or more are withdrawn before the race, be sure to specify in writing to the secretary which ones are being withdrawn. Nominations or subscriptions to this race may be canceled by owners without liability at any time prior to the actual running thereof except there will be no refund of any entry fees or membership dues.

All nominations and sustaining payments should be sent by registered or certified mail. Nomination, sustaining, and penalty payments must be postmarked on or before payment dates specified. Sunday and postal holidays excluded. The sender's receipt must be presented as proof of payment should any discrepancy occur. There will be no refund of fees. All checks returned by the bank will constitute no payment. Issuance of an "NSF CHECK" or stopping payment on a check tendered to cover any fee shall be absolutely prohibited.
