TERMS AND CONDITIONS

1. **SERVICES SOLD ARE FOR THE 2012 SEASON**, with live foal guarantee, only to the extent of one (1) return in the following year with the same mare, or a substitute mare, in case of death or vet-certified breeding unsoundness. Should the mare presented to the stallion by the person who purchased the service not conceive the first year, this person will have the right to present the same or a substitute mare (as described above) to the same stallion the second year for breeding. This, and only this, foal will be allowed to move its eligibility to the following years race, and this move will be allowed only one time. No other foals will be allowed to change eligibility years unless the stallion meets all requirements the following **year**.
2. **BREEDINGS TO BE SOLD AT AUCTION**. The Kansas Quarter Horse Racing Association will advertise all breeding services donated. The Association will make every effort to sell the breeding. For every donated breeding with **NO CONDITIONS** (ie: minimum bid, full fee, farm fees, chute fees, etc.), all 2013 AQHA offspring of that stallion will be eligible for the Kansas Jackpot and Jackpot Prep Futurities and Derbies. If the service of the stallion, donated **WITH CONDITIONS**, does not sell, the owner will need to make a donation to the KQHRA of one-half the publicly advertised breeding fee or \$500, whichever is greater to make the 2013 offspring of this stallion eligible for the KQHRA races.
3. **BREEDING NOT TO BE SOLD AT AUCTION**. The stallion owner has the option to make the 2013 AQHA offspring of the stallion eligible for the KQHRA races by donating to KQHRA one-half of the publicly advertised breeding fee or \$500, whichever is greater. **UNDER THESE TERMS DONATIONS MUST ACCOMPANY THIS FORM.**
4. **BREEDING FOR THOROUGHBRED MARES**. Donated AQHA stallion-breeding services will be for AQHA or thoroughbred mares. Thoroughbred stallions will be for AQHA mares only unless the stallion owner specifically agrees to allow thoroughbred mares to be bred. The resulting TB foals will not be eligible for the Jackpot races.
